Processing of Files received on Regional Holidays

NPCI is thankful to you for the support and encouragement for making the National Automated Clearing House (NACH) a successful platform for processing of payments which are bulk and repetitive in nature. It is our endeavor to provide the best of services to the member banks and ensure that the improvement in quality at all times.

- 2. We draw your attention to clause13 (Clearing Timings) of Procedural Guidelines of NACH system where in it is decided that NACH system will work on all days except Sundays and Holidays as defined by RBI for RTGS.
- 3. It has been observed that a few member banks are not making necessary arrangements for processing the inward transactions on local holidays though they don't fall under the RTGS holidays (extract of the clause in Annexure I). Transactions processed through NACH system pertaining to various products need to be settled and returns should be submitted on the same day. Any laxity on this part will lead to delayed credit and late returns causing inconvenience to the customers and government departments for subsidy related payments.
- 4. All member banks are requested to ensure that sufficient staff is available on all the working days of NACH (non-RTGS holidays) so that the inward transactions are processed on time. We are attaching the list of RTGS holidays 2014 for your kind reference.
- 5. Request all member banks to take a note and ensure compliance.
