ECS Debit - City Wise Inward Generation

Madam / Dear Sir,

Reference to the Circular no 111 dated July 21, 2015 on the ECS Debit product migration to NACH. We are ready with the functionality for generating the ECS center/region-wise inwards to the destination Banks based on mapping of the city code available in MICR to the respective RECS cities. Note that there is no change in the file format.

Please refer the Annexure I for region wise ECS naming convention. This facility will be enabled to the member banks on a specific request. Once it is enabled the member banks will receive city wise inward in a zipped format which will be pushed to the banks SFG from where it can be downloaded and extracted for further processing. If the member Banks would like to discontinue this facility then they can send a request to ach@npci.org.in.

Please refer to Annexure II for the list of ECS centers and the corresponding city codes mapped against the respective centers. In case of any other locations to be added, please write back to ach@npci.org.in.

Member banks are advised to note that there is no change in the existing process of the settlement entries posting as consolidated entry per bank.

Annexure I

If the Bank has 4 ECS inward files which contains transactions of 2 regions each namely Chennai and Mumbai. The convertor will generate only 2 inward files one for Chennai region and other of Mumbai region.

- A separate file will be generated for the transactions with the city codes which are not mapped to any regions.
- Region wise inward file will contain maximum of 20,000 records. In case a region is having more than 20000 transactions then multiple file will be generated for a same region.
- Header and Trailer of the inward file will be same as the original INW file, only the total item and total amount will change according to the generated file.
- Region wise inward file name will be formed as below
 - ECS-(CR/DR)-<BankShortCode>-<BusinessDate>-<RegionName><SeqNo>-INW.txt
 - Example:
 - ECS-DR-HDFC-13102015-CHENNAI00001-INW.txt
 - ECS-DR-HDFC-13102015-CHENNAI00002-INW.txt

Others:

ECS-DR-HDFC-13102015-UNMAPPED00001-INW.txt

- The converted files will be signed and a zip file will be created based on the region with the file name as
 - ECS-(CR/DR)-<BankShortCode>-<BusinessDate>-<RegionName>-INW.Zip
 - o Example: ECS-DR-HDFC-13102015-CHENNAI-INW.Zip
- All the region's zip files will be combined for a destination bank with the file name as ECS-<CR/DR>--<Bank Code>--<Business Date>-INW.zip
 - Example: ECS-DR-HDFC-13102015-INW.zip
- The Combined zip file will be sent to destination bank SFG mailbox.
- A summary report which shows the set of input files processed and output files generated with the Item Count per file and Amount per file will be sent to destination Bank SFG mailbox.
