**New CBS Account numbers for Postal Accounts**

Reference is drawn to the DO letter no 01-03/2016-DBT Cell dated November 6, 2017 from DDG - RB & Planning of Department of Post.

As you are aware that GPO (India Post) is a participant in NACH platform and has been enabled to process both Aadhaar based (APB) as well as Account based (ACH) CR transactions as a destination bank for credit of benefits to the account holders of Postal Savings Bank Accounts (POSB).

The account numbers pertaining to GPO that are in circulation with the banks and other corporates are non-CBS account numbers. In order to enable GPO to process Account based credit transactions the account numbers provided in the Inward file need to be CBS account number.

There may be lot of beneficiaries/payees' holding account with GPO (India Post) receiving benefits with old non CBS (Sanchay Post) account numbers in off-line mode. There is a need to update the data base of Agencies with new CBS account numbers for routing transactions through NACH and comply with the guidelines on DBT and others.

As advised by Postal Department the Agencies should approach the nodal officers (list in Annexure I) of different states, provide the details in the enclosed format (Annexure II) to receive the new CBS account numbers for updation of beneficiary database suitably to avoid transactions getting returned.

Sponsor banks are advised to disseminate the information and encourage the Corporates/Other Implementing Agencies to undertake this one-time activity to enable seamless credit transactions to the account holders of GPO with minimal error.
