Sub: Reporting of ATMs Location details by NFS members.

We refer OC 160 dated 16^{th} April 2015 on the subject of reporting of Geographical Deployment of ATMs in the country.

NFS Members are currently reporting every month to NPCI, number of ATMs deployed by them along with the geographical classification as per OC 160.

RBI has instructed NPCI to collate complete ATM location including geographical classifications of the ATMs deployed by NFS members across the country. This information is required to understand the geographical dispersion/deployment of ATMs across the country and to plan and strategise deployment of ATMs throughout the country. NPCI is required to report the details of ATMs deployed by NFS members on a monthly basis to RBI.

We, therefore, request you to submit complete location details of ATMs deployed as at the end of each month. The details need to be submitted by the 10th of the month following in the excel format (refer Annexure A) by email. We will compile the information submitted by banks/WLAOs and arrange to forward the consolidated report to RBI.

Please note that RBI needs the correct and complete information every month. Hence, we will require the wholehearted support of all banks/WLAOs for timely submission of the information so as to meet RBI's requirement and deadline.

The information called for as above should be sent to the following NPCI officials latest by 10^{th} June 2015 for ATMs deployed upto 31^{st} May 2015:
