Dear Sir / Madam,

Sub: NFS - BIN Addition & Maintenance -6/8 digits BINs

Members may start issuing 8-digit BIN cards from April 2022 onwards. NPCI supports routing of 6 as well as 8 digit BINs in NFS ATM network. There shall be no change in the existing settlement, reconciliation and dispute management process for member banks.

Members should ensure the following:

As Issuer:

- To ensure that all 6/8 digit BINs on which your Bank have issued cards are updated in NFS BIN Master File (available on NFS BCS portal) for routing of ATM transactions.
- In case, any BIN is not updated in NFS, the details of such BIN should be submitted to NPCI using the 'BINs on-boarding Form' (Refer <u>Annexure A</u>) as per the existing process.
- In case, any bank surrenders the existing 6 digit BIN and issues cards on new 8 digit BIN, request for BIN deletion for the surrendered 6 digit BIN (Refer <u>Annexure B</u>) and BIN addition request for new 8 digit BIN should be submitted to NPCI. This shall also apply for cases where Bank start issuing 8 digit BIN cards for the existing 6 digit BIN and are surrendering part of the 6 digit BIN range to Network/Scheme.
- Please note that if the BIN which is surrendered is the settlement BIN at NFS, though it can be deleted for online transactions, however it shall remain enabled in NFS backoffice for settlement purpose till the end of dispute life cycle. (Member may contact NPCI for information on settlement BIN for the Bank, if required)

As Acquirer:

 Acquirer members should ensure that all the 6/8 digit BINs communicated by NPCI for addition/deletion through emails and/or through BIN master made available in BCS,

- should be updated at acquirer within 5 calendar days for routing the transactions to NFS.
- Members to make necessary changes at their end, if any, to facilitate routing of 6/8 digit BIN card ATM transactions to NFS.
