Sub: Interbank Mobile Payment Service (IMPS) for Merchant Payments and IMPS activation from other channels

NPCI has received the approval from Reserve Bank of India for extending the capabilities of IMPS and to add the following additional services:

## 1. Merchant Payments

This would facilitate making Person to Merchant (P to M) payments like Utility bill payments, payments at shop floor, payment of fees to various institutions, donation payments etc. irrespective of with which bank the merchant maintains banking relationship. Merchants can also pull the transactions from the registered subscribers with subscriber confirming the payment requests.

## 2. Initiation of IMPS transaction through ATM and Internet channel.

With this approval, customers can initiate IMPS transactions from ATM and Internet Banking Channel. This additional capability to initiate transactions through alternate channels would indeed provide the necessary impetus for increasing the transactions through IMPS. The customers, who are not in the position to download the mobile banking client application on the mobile handset, can make use of the ATM/Internet Banking to effect the payment. The destination account would be identified by the mobile number and MMID. Thus, the features of real time payment and 24X7 availability would be extended to payments initiated from ATM and Internet Banking channel.

The copy of the approval letter from RBI vide letter No DPSS.CO.PD.2463/02.17.001/2010-2011 dated April 27, 2011 is enclosed.

NPCI will conduct a pilot with 4 to 6 banks with 2 to 3 merchants. IMPS through ATM and Internet Banking channels would also be tested through 4 to 6 banks.
