**Sub: IMPS – List of holidays which are considered as non-working day and excluded for levying penalty**

Please refer to circular NPCI/IMPS/OC No. 65/2015-16 dated 24<sup>th</sup> November, 2015 regarding implementation of penalty for not raising TCC/RET within T+1 working day for all IMPS time-out transactions by banks as beneficiary.

Please note that IMPS settlement system (DMS/RGCS) will consider three type of holidays as non-working day and such holidays will be excluded for levying penalty.

- 2<sup>nd</sup> & 4<sup>th</sup> Saturday of every month
- Sundays
- RTGS holidays

**Regional holidays are not considered as non-working days.**

Kindly make a note of the above and ensure to reconcile all the time out/deemed approved transactions within the T+1 working day (please refer OC NPCI/IMPS/OC No. 65/2015-16 for details) to avoid payment of penalty.
