Dear Sir/Madam,

NUUP-Banks Short name Implementation as an alternative to access NUUP service

Currently in NUUP (*99#), remitter's bank is identified using the 1st four letter of IFSC. The users have to type the 1st four letter of IFSC after receiving the NUUP welcome screen to receive their respective bank's menu. However, with this identifier, we are experiencing many transaction declines owing to wrong/no user input at the NUUP welcome screen. This is due to either customer's not knowing or not remembering their bank's IFSC.

2. This issue was deliberated & discussed during the last IMPS Steering Committee. It was decided by the committee that NUUP should have, "three letters bank short name", as an alternate bank identifier for user to access the bank menu. This option will also be used as a bank identifier, in addition to existing 1st 4 letters of IFSC for user to access the bank menu on NUUP. The complete list of bank's Short name and 1st 4 letter of IFSC is enclosed as Annexure A.

3. We wish to inform the member banks that this new addition of having bank short name as the bank identifier has been implemented from 16th April, 2016.

Following is new verbiage of NUUP welcome screen:

Welcome to NUUP. Now Enter 3 Letters of your Bank's short name or first 4 Letters of your Bank's IFSC

For e.g., a Punjab National Bank customer can access welcome menu by entering either PNB (short name) or PUNB (1st 4 letters of IFSC).

4. We, therefore, request members to take note of this change & inform your internal ecosystem. We also request members to communicate this change to your respective customers so that they can get benefited from this new addition. We are confident that this simplification will be helpful for the entire NUUP ecosystem and will help us in reducing the transactions decline occurring due to erroneous user inputs.
