**Sub: IMPS - Implementation of 4<sup>th</sup> settlement - Effective from 3<sup>rd</sup> Aug 2015**

Presently, IMPS settlement is processed thrice a day i.e. morning at around 09:00 hrs., afternoon at around 14:00 hrs. and evening at around 18:30 hrs. (Refer operating circular NPCI/IMPS/OC No 37/2014-15 dated May 27, 2014 for details). The settlements are processed through member banks' RTGS a/c maintained with RBI. Settlement reports are made available to all member banks through DMS for each settlement cycle.

In the IMPS Steering Committee meeting held on 29-Apr-2015, implementing four settlements in a day was approved whereafter we sought RBI approval. We are pleased to inform that we have since received RBI approval for executing four settlements in a day for IMPS.

**DAILY LIMITS**

Presently, daily limits are refreshed at the time of each cut off i.e. at 23:00 hrs, 12:00 hrs. & 17:00 hrs. With the implementation of four settlements, the daily limit shall be refreshed at the time of each cut off time i.e. at 23:00 hrs., 10:00 hrs., 14:00 hrs. & 17:30 hrs. (Please refer to Annexure – 1 for details).

Any adjustments (Returns, Credits, Chargebacks, Representments, etc.) posted in DMS from 00:00 hrs. to 24:00 hrs. shall be settled in the first settlement cycle for which settlement entries are posted at around 09:00 am. Thus, settlement files posted for 2<sup>nd</sup>, 3<sup>rd</sup> & 4<sup>th</sup> settlement shall not contain any adjustment entries.

There will be no change in the raw data file contents and the file formats. The raw data files, settlement files, verification files and daily settlement report (DSR) will be available as per the cut-off covering each settlement cycle. Service tax reports shall be provided on monthly basis as per the present practice.

**Effective Date:**

The above process will be implemented with effect from **3<sup>rd</sup> Aug 2015**.

All are requested to take a note of the above and ensure that reconciliation process is suitably handled.
