## Closure of RuPay Insurance Program: FY 2017-18

- This is with reference to RuPay Insurance Program FY 17-18 (Circular: RuPay / 2017-18/002 dated 26<sup>th</sup> April, 2017) which was launched as a value added service to provide insurance cover of Rs.1 Lac for Non-Premium cards and Rs.2 Lac for RuPay Premium cards (accidental death or Permanent Total Disablement only) to eligible RuPay Cardholders.
- 2. As per the terms & condition of RuPay Insurance Program 2017-18 <u>"Any claims reported after 120 days from the date of policy period shall not be eligible for compensation under the RuPay Insurance Program 2017-18".</u> The claim intimation time period of 120 days for the expiry of RuPay Insurance Policy 17-18 falls on the 29<sup>th</sup> of July 2018.
- In view of the above, claims for the accident that have occurred on or before 31 March, 2018 and intimated after the cut-off date i.e. 29<sup>th</sup> July 2018 shall not be accepted for processing.
- 4. All member banks are requested to take note of the above and are also requested to communicate the same to their branches and customer service team suitably.
