# Sub: <u>Revision of Incoming file Naming convention for Offline Presentments, to help Issuers clearly</u> <u>distinguish, identify and consume for processing</u>

Network Incoming files are generated by the BCS RGCS settlement system and shared with the Issuing members after each settlement cycle. RuPay currently generates two incoming files for the Issuing members as detailed below, subject to transaction availability.

- 1. All Offline Presentments claimed by the Acquiring Members for the cycle.
- 2. All other incoming instructions as applicable.

### **Existing Functionality**

Both incoming files follow the same File Naming convention as detailed in the "RuPay Global Clearing and Settlement Technical Message Specification" document as tabulated below.

File Type	01	01 – signifies that this file is a network generated incoming message	
Clearing Cycle Number	1 or 2	<ul><li>1 – signifies the first clearing cycle</li><li>2 - signifies the Second clearing cycle</li></ul>	
Participant ID of Member	ABCD2110002	This is the participant ID assigned by NPCI to the member. It identifies the member who will be receiving this file	
Julian Date	11213	Format = YYDDD, i.e. year = 2011 & Julian date = 213 i.e. 1st August	
Sequence Number	00 or 01	<ul> <li>00 – signifies that this is the first incoming file that has been generated for this particular participant for the specified Julian date.</li> <li>01 – signifies that this is the second incoming file that has been generated for this particular participant for the specified Julian date.</li> </ul>	

Sample files names where both offline and normal incoming file is generated in the same settlement cycle.

## **Revised Functionality**

For better clarity, ease of identification and consumption, the file naming convention for offline presentments have been revised as below.

Description	<u>Value</u>	Interpretation
File Type	05	05 – signifies that this file is a network generated offline incoming message
Clearing Cycle Number	1 or 2	<ul><li>1 – signifies the first clearing cycle</li><li>2 - signifies the Second clearing cycle</li></ul>
Participant ID of Member	ABCD2110002	This is the participant ID assigned by NPCI to the member. It identifies the member who will be receiving this file
Julian Date	11213	Format = YYDDD, i.e. year = 2011 & Julian date = 213 i.e. 1st August
Sequence Number	00 or 01	<ul> <li>00 – signifies that this is the first incoming file that has been generated for this particular participant for the specified Julian date.</li> <li>01 – signifies that this is the second incoming file that has been generated for this particular participant for the specified Julian date.</li> </ul>

Sample file names where both offline and normal incoming file is generated in the same settlement cycle.
