This is with reference to NPCI's RFP#2011-12/0019 dated 29th Feb, 2012 for Engaging Agencies for Certification. The prospective bidders may please note that:

For Bouquet A all the work would be carried out from bidder premises only.
For Bouquet B, NPCI would either opt for one or both of the options as given below.

In either of these options no minimum commitment regarding number of resources to be deployed or certifications to be carried out during period of contract would be offered by NPCI.

Option 1 (For Bouquet B):

Bidder should deploy resources at NPCI premises (either at Mumbai or Chennai or at both locations). One project manager should also be deployed wherever resources are deployed if NPCI requires the same. Project Manager so deployed should have minimum experience of 3-4 years for undertaking most of the services as sought in the RFP. NPCI would make payment on monthly arrears basis per resource.

Option 2 (For Bouquet B):

All the services as mentioned in Bouquet B would be carried out from bidder's premises. Connectivity (network equipments, network links and their monitoring/maintenance) between NPCI office and bidder's premises would be done by NPCI.

Bidder shall submit masked price bid in Envelope B. which is part of technical evaluation

Hence Annexure-2 Commercial Bid format for Bouquet A and Bouquet B will be revised accordingly.

All other terms and conditions remain unchanged.
