

Notification pertaining to Request for Proposal

for supply and installation of servers

About NPCI:

National Payments Corporation of India (NPCI) is a company registered under Section 25 of the Companies Act, 1956 with its Registered Office in Mumbai, India. NPCI is promoted by 10 banks in India under the aegis of the Indian Banks' Association with majority shareholding by Public Sector Banks.

The 10 promoter banks are State Bank of India, Punjab National Bank, Canara Bank, Bank of Baroda, Bank of India, Union Bank of India, ICICI Bank Ltd, HDFC Bank Ltd, Citibank N.A, and HSBC. The vision, mission and objectives of NPCI are to operate for the benefit of all the Member Banks and the common man at large.

Objective of this RFP:

National Payments Corporation of India proposes to procure Servers with 3 years comprehensive onsite Warranty. Initial Purchase Order will be for 5 servers. NPCI will place Purchase Orders with the selected Bidder for further requirements during the period of six months from the date of Notification of Award / Purchase Order, at the agreed unit rate i.e. the rate contract for a period of six months. The Bidder should have adequate experience as sought in the RFP to undertake the activities.

Cost of the RFP:

The Bidder shall bear all costs associated with the preparation and submission of its bid and NPCI will, in no case, be held responsible or liable for these costs, regardless of the conduct or outcome of the bidding process.

The Bidders can procure the RFP document from NPCI's office at13th Floor R- Tech Park, Nirlon Knowledge Park, Near HUB Mall, Opp. Western Express Highway Goregaon(E), Mumbai – 400 063.on payment of non-refundable amount of □3,000/- (INR Three Thousand only plus taxes), payable in the form of Demand Draft/Pay order from any Scheduled Commercial bank in India favouring "NATIONAL PAYMENTS CORPORATION OF INDIA" payable at Mumbai. This RFP document is non-transferable and cost of RFP document is non-refundable.

RFP document containing detailed specifications and requirements with terms and conditions can be obtained by eligible Bidders on any working day during office hours from

10:30 hrs to 18:30 hrs till the stipulated last date for the purpose, on payment of RFP cost in the form of Demand Draft / Pay Order.

Due Diligence

The Bidders are expected to examine all instructions, terms and specifications stated in this RFP. The Bid shall be deemed to have been submitted after careful study and examination of this RFP document. Failure to furnish all information or submission of a bid not responsive to this RFP will be at the Bidders' risk and may result in rejection of the bid. NPCI is not bound to disclose the grounds for rejection of Bid. The decision of the NPCI regarding the final declaration of the successful Bidder shall be final.

The Bidder is requested to carefully examine the RFP documents and the terms and conditions specified therein, and if there appears to be any ambiguity, contradictions, inconsistency, gap and/or discrepancy in the RFP document, Bidder should seek necessary clarifications through Pre-Bid queries.

Ownership of this RFP

Scope of Work

Scope of Work – Summary

The scope of the work is Supply and Installation of the servers and to provide maintenance support for the servers during the warranty period of 3 years from the date of acceptance of the systems at the Data Centers of NPCI at Mumbai, Chennai and Hyderabad. Bidders should provide comprehensive onsite support Warranty for 3 years with next business day response and Response time of 4 hours and resolution time of 12 hrs. NPCI will procure Windows server Operating Licenses separately, but the bidder is required to provide support for installation for the Operating System.

NPCI reserves the right to place Purchase order to the successful Bidder for any further requirement of servers at the agreed unit rate i.e. the rate contract for a period of six months from the date of first Purchase Order.

Single Point of Contact

The selected Bidder shall appoint a single point of contact, with whom NPCI will deal, for any activity pertaining to the requirements of this RFP.

The selected Bidder shall provide support services which include installation of servers by providing onsite support on next business day response and resolution at Mumbai, Chennai and Hyderabad for a period of three (3) years from the date of acceptance of the hardware and software. In case of any failure of Hard Disk during the warranty period then the Bidder shall replace such Hard Disk with new Hard Disk. NPCI will return the hard disc after physical damage of old Hard Disk during the warranty period.

Eligibility Criteria

Pre-requisite:

The Bidder should possess the requisite experience, resources and capabilities in providing the services necessary to meet the requirements, as described herein. The Bidder should also possess the technical know-how and the financial wherewithal that would be required to complete the scope of work. The Bid must be complete in all respects and should cover the entire scope of work as stipulated in the document. Bidders not meeting the Eligibility Criteria will not be considered for further evaluation.

Eligibility Criteria:

The invitation to Bid is open to all Bidders who qualify the Eligibility Criteria as given below:

1. The Bidder should be a company registered under the Companies Act, 1956 since the last three years.

2. The Bidder should have minimum annual turnover of □5.Cr during the last three financial years (2009-10, 2010-11, 2011-12) or calendar years 2009, 2010, 2011 or bidder's financial years.

3. The Bidder should be a profit (profit after tax) making company in the last financial year i.e. 2011-12 or calendar year 2011 or the Bidder's financial year.

4. The Bidder should be authorized business and support partner for OEM equipment.

5. The Bidder must provide references of two clients who have procured servers from them.

6. The Bidder should not be currently blacklisted by any bank / institution in India or abroad.

Eligibility Criteria Response Sheet

1. The Bidders should complete the Eligibility Criteria Response Sheet as given in Annexure - E.

2. Failure to provide the desired information and documents may lead to disqualification of the Bidder.

Technical Requirements

Servers shall be delivered at NPCI's Data Centres / offices at the addresses mentioned in Purchase Order, with the possibility of extending to another office which might come up in the near future.
