6. If the successful bidder does not deliver as per the above schedule of delivery period or the extended period for delivery as may be permitted in writing by NPCI. NPCI shall impose a penalty @at the rate of 0.5% for each week's delay subject to a maximum of 5% of the total purchase order value of the items shall be recovered for delayed deliveries, without prejudice to any other right or remedy available under the Purchase Order.
7. Inspection of said items shall be carried out at NPCI. Bidder shall replace the damaged /rejected items to the satisfaction of NPCI without any extra cost.
